





I. BOOKING & CANCELLATION

Ia. All bookings may incur a booking fee or security deposit at the discretion of management.

However, prices and menu items are subject to change without notice to cover any unforeseen supply issues, quality issues or changes in price. Reasonable attempts to contact the client will be undertaken in the event of any changes. 2e. All prices are valid from 30 days of quote. Thereafter a new quote will be provided.
